Please note: Venue Hire is for a period of 8 hours only (from start of ceremony time, regardless if it starts later than arranged) - refer to the "Wedding Package".

Note: Final arrangements 2 weeks prior to wedding day - any alterations after this, will be quoted extra.

Full payment must be made 14 days prior to the Wedding. Late payments or outstanding amounts of the Venue Hire or Final Account will be levied with a penalty fee of 20% on the outstanding amount and administration costs of R500, 00.

NO ALCOHOL IS TO BE BROUGHT ONTO THESE PREMISES – ANYONE NOT COMPLYING WITH THIS, WILL BE REMOVED FROM THE PREMISES IMMEDIATELY.
