TERMS AND CONDITIONS:

1. Tuition fees paid monthly should be paid in advanced before the 7th of each month. A 10% interest will be charged after the 7th.
 2. Should the student be in arrears of payment he/she will be dismissed from class.
 3. Should the student be unable to attend classes, notice should be given to the teacher in order to prevent forfeiting marks. More than 5 classes missed, a 10% Mark will be deducted from the final exam.
